

## 2009 USAWS - AWARD OF MERIT

### Charlotte Melchers



In the late 70's Charlotte purchased a ski boat and began teaching young adults and children to ski. She became a member of the Gold Coast Ski Club, which began her long and dedicated service to the sport. With the help of Elmer Stailing she took over running tournaments and put the club back in the good graces of AWSA as they had been denied tournament sanctioning. She spent many years with the club as treasurer, tournament chairman and a few years as show director.

1982 ----- Through Charlotte's direction the GCSC went to Jim McCormick's in Plant City as the working personnel needed to run the South Regional Tournament. Upon the death of young Jimmy 2 weeks before the tournament, with Charlotte's guidance GSCS was able to pull the tournament together.

1983 ----- Charlotte along with other Gold Coast members acquired Mills Pond Park, Lake Lauderdale site for use of the GSCS.

1990 ----- Charlotte moved to Boynton Beach and became very active in the Ski Club of the Palm Beach serving on the Board of Directors, also serving as President and Treasurer for many years.

Over the years the Ski Club of the Palm Beaches and Okeeheelee Park, under the leadership of Charlotte as the Tournament Director of most events, hosted

Five Southern Regional Championships - 1984, 1993, 1997, 2000, 2002

Ten National Championships - 1986, 1987, 1988, 1994, 1995, 1997, 1998, 2004, 2005, and will be hosting the 11<sup>th</sup> one this year, 2009.

One World Championship - 1989

Three professional tournaments - the first pro tour stop, 1984; the first U.S. Open, 1986; the first America's Cup, 2000

## **Award of Merit Criteria**

The award of merit is awarded each year to a person active in USAWS. It emphasizes participation at the board level (USAWS or Sport Division) and does not necessarily require participation as an athlete. The committee should consider volunteerism as an official, committee person, or sport division board member. The award of merit should be given to the USAWS member that has given back to the sport at multiple levels. Regional through National participation should be considered. Volunteerism in any sport divisions should be weighed by the committee.

Nominations should be sent to USAWS (Awards Committee Chair) by August 1 and should include all information available about the nominee. Information should include but not be limited to: tournament official experience at regional National or World level, Local Club participation, state or Regional offices held, and National board positions held throughout the nominee's life. Include regional and national committee work as well as any honors or awards previously received by the nominee.
