- 1. Opening
- 2. Call to Order & Remarks/Announcements
 - a. Bob Harris began the meeting with general remarks.
 - i. The summer meeting is intended to be relatively short, with more time intensive material/discussions covered at the mid-winter meeting.
 - ii. Thanks to Lyman and Taylor Hardy for hosting Regionals this year.
- 3. Appointment of Parliamentarian
 - a. Jim Jaquess served as parliamentarian.
- 4. Introduction & Roll Call
 - a. Attendance can be found below.
 - b. Bob Harris verified which committee chairs were present. This is incorporated in the list below.
 - c. Craig Bryans has taken over the Seeding committee from Kirby Whetsel.
- 5. Announcement of Quorum
 - a. Quorum was established.
- 6. Review and Approval of Agenda
 - a. Joy Coomes made a motion to approve.
 - b. Kirby Whetsel seconded the motion.
 - c. The motion passed with none opposed.
- 7. Review and Approval of 2022 Mid-Winter Meeting Minutes
 - a. Pat Coomes made a motion to approve.
 - b. Ray Crenshaw seconded the motion.
 - c. The motion passed with none opposed.
- 8. Treasurer's Report
 - a. Cynthia Logan provided an update. Documentation attached.
 - b. Cynthia discussed changes from 2021 to 2022.
 - i. Junior Development expenses
 - ii. Budgeted tournaments
 - iii. Items of discussion included:
 - 1. Regional and state clinics should be moved from the Junior Development budget to the general budget. This will be finally addressed by Winter meeting

- 2. Grant for the Southern Regionals \$2,000. Approved by the Council for the last several Regionals.
- 3. Website hosting is a little more expensive this year.
- iv. Lyman Hardy made a motion to approve.
- v. Rodger Logan seconded the motion.
- vi. The motion passed with none opposed.
- 9. Report of Executive Vice President
 - a. Bob Harris gave a high level summary of the "Summer 2022 EVP Newsletter" that was distributed prior to the meeting.
- 10. 2022/2023 Southern Regionals
 - a. Update from Lyman Hardy.
 - i. Lyman provided a few remarks related to the financial impact of Regionals this year.
 - b. Bob Harris announced Lymanland USA would be allowed to reopen its Regionals bid at the mid-winter meeting if necessary.
 - c. Chris Hall expressed his desire for the Region to provide some sort of supplement to Lymanland USA to ensure the tournament does not put the LOC in the red. This will be addressed after financials from this year's Regionals have been finalized.
 - d. Rodger Logan brought up the possibility of raising entry fees for Regionals to further support the LOC.
- 11. Report of Federation Presidents
 - a. States that submitted reports: Alabama, Tennessee. Reports attached.
 - b. The USA Adaptive Waterski & Wakesports Nationals will be held in Paducah, Kentucky from September 14th 17th.
 - c. Lymanland USA is hosting the Malibu Open in the fall.
- 12. Committee Reports
 - a. PanAm Dana Garcia (joined virtually)
 - i. Discussion on:
 - 1. Inequality in the voting process between the United States and the Latin American countries. Pairing up with Canada doesn't necessarily eliminate these issues, though. We need to be cautious.
 - 2. How many federations are in the PanAm Federation?
 - a. 16 federations
 - b. You have to hold a certain number of events to have a certain number of votes. Some events should be looked at with a closer lens.
 - 3. Straw vote:
 - a. Vast majority in favor of splitting away into a separate region.

 - i. No report.

- e. Boat Drivers Eric Kelley
 - i. The driver's policy manual has been updated with a few updates to testing procedures.
 - ii. SurePath and WSTIMS bugs have been addressed.
- f. International Activities Lyman Hardy
 - i. PanAm
 - 1. Currently exploring splitting the United States and Canada into a separate region to give us more voting power and influence. This would split us away from PanAm (North America and Central America). This is in the beginning stages.
- g. Bylaws, SR, AWSA, USA-WSWS Jeff Clark
 - i. No report.
- h. Judges & Scorers Ray Crenshaw
 - i. Report attached.
 - ii. Practical testing is up. Our goal is to add functionality to the website so tests can be taken directly in the Learning Management System portal (under development), as opposed to YouTube or via CDs.
 - 1. It's challenging to police international officials' adherence to SafeSport. Efforts ongoing.
 - 2. Changing the fast track process to incorporate some minimum requirements for both regular and senior officials.
 - iii. Bob Harris shared a few thoughts:
 - 1. I'm very much in favor of the open or elite skiers being able to fast track, but there needs to be some experience with administrative skills prior to being a Chief Judge. Maybe work a few tournaments as Assistant Chief Judge.
 - iv. We picked up a few new PanAm judges over the last couple of years, including Rodger Logan, Russell Gay, and Jazmine Gagner, to name a few.
 - v. Cynthia Logan shared: "We're working to develop the PanAm scorers program."
- i. Junior Development Allison Blair
 - i. Junior Development party going on during the meeting.
 - ii. Review of the mid-winter meeting minutes section on Junior Development expenses. Note: This is being resolved, and the P&P will be modified at the Winter meeting to clarify budgets.
 - iii. Allison is passing the Southern Region Junior Development chair to Shannon Waters as Allison is taking on national Junior Development responsibilities.
 - iv. Both national and regional clinics were held this past year.
 - v. Scholarship Elmer Stailing Scholarship went to Nicholas Kerr.
 - 1. This scholarship must go to a Southern Region skier.
 - 2. We have one more year to award it. Will require funding next year to continue.
 - a. This will be voted on at a later date.
- j. Nominating Committee Kirby Whetsel
 - i. We are looking for a candidate for Chairman of the Board of AWSA.

- ii. Doug Robbins has been considered, as have others.
- k. Rules Scott Snape
 - i. No report.
- l. Technical Rodger Logan
 - i. We've rolled out a handful of new programs this year from Chip Shand.
 - ii. Chip is offering free programs for video gates, video tape measure, and video stopwatch.
 - iii. They are available on the USA Waterski website.
 - iv. Rodger Logan I plan on nominating Chip for AWSA Volunteer of the Year.
- m. Safety James Cawthern

- n. Seeding Craig Bryans
 - i. A lot of scorers continue to send Kirby Whetsel seeding info. Please send this information to Craig from this point on.
 - ii. Craig's goal is to get tournament scores posted around in 24 hours.
- o. Skiers Qualification Kirby Whetsel
 - i. No report.
- p. Towboat/Speed Control Greg Webb
 - i. Greg mentioned the LOC reimbursement items Will Bush previously shared.

 - 1. Lyman Hardy They started a GoFundMe page and were able to gather the money they needed.
